

TOWN OF WILLINGTON **BULKY WASTE POLICY**



The following items are allowed in the bulky waste bins:

(please note: only 3 cubic yards of material is allowed per week)*:

• Furniture • Household Items • Demolition Debris

*Please note that bulky waste in amounts exceeding 3 cubic yards will not be accepted unless specifically charged for. Please ask for assistance if there are any questions. Bulky items in working order may be placed in the Swap Shed per Transfer Station Attendant's approval. There is a charge for some bulky waste items, see sign at Transfer Station.

The following items are NOT allowed in the bulky waste bins:

· Chemicals · Industrial waste (including sludge) · Motor Vehicles and motor vehicle parts · Stumps · Explosives & live ammunition • Hazardous waste/ hazardous materials including medical waste • Waste collected from septic tanks • Rocks, stones or boulders • Grass clippings and leaves • Clean fill • Animal remains/ excrement • Recyclable items, i.e.: appliances, automobile batteries, corrugated cardboard, scrap metal.

- Bulky Waste Procedure:

 Bulky waste gates are to be closed at all times. Large items that cannot be lifted and dumped over the gates should be left to the side. Please do not lean against the gate and keep hands and feet off of them. please ask the Transfer Station Attendants for assistance with heavy items.
- Bulky loads will be checked for their source of origin by a Transfer Station Attendant. Depending on the nature of the refuse, the Transfer Station Attendant may ask to see a building permit. Any refuse found to be brought in to the Willington Transfer Station from other towns will result in a termination of your permit and your right to dispose of any refuse at the Willington Transfer Station. A fine of \$90 will be charged and a \$500 bond posted before the Board of Selectman will consider reissuing a permit.
- The dumping of large loads of bulky waste needs to be inspected and supervised by a Transfer Station Attendant. Transfer Station Attendants are the only people authorized to open/close gates.
- <u>Please wait for a Transfer station Attendant to be available to punch your card.</u> Every Willington household is eligible to receive a bulk waste punch card each calendar year. Bulky waste permit cards can be obtained by the Transfer Station Attendants by the Transfer Station Attendants.
- A fee of \$50 will be collected for all loads in excess of 3.0 cubic yards per week. Additional increments of 3.0 cubic yards will require additional fees. Example: if a resident disposes of a load totaling 9 cubic yards, the first 3 cubic yards are not subject to a fee, however, the remainder of the load 96 cubic yards) is subject to a fee of \$100.

Always ask if in doubt Bring your punch card and your permit(s) Can dump 3 yards per week
